ACTION REQUIRED

2024-2025 NYS Prekindergarten Final Program Report Now Available

- In accordance with Education Law §3602-e(13), all LEAs receiving UPK/SUFDPK funding are required to submit a Final Program Report annually.
- The 2024-2025 NYS Prekindergarten Final Program Report survey is now available to be completed in the SED Monitoring and Vendor Performance System (MVPS).
- **Final Program Report submissions are due by July 31, 2025**
- Please note that staff must have a district-level SEDDAS account to access this survey. Please refer to the SEDDAS User Guide and the MVPS Quick Guide for further information on creating SEDDAS accounts.

MUST KNOW

Official Transcripts Required for Teaching Assistant (TA) Applications

- All TA applications filed on or after **June 1, 2025**, will require official transcripts sent to the Office of Teaching Initiatives (OTI).
- Photos of diplomas will no longer be accepted for applications filed on or after June 1, 2025.
- Official transcripts can be transmitted to OTI in the following ways:
 - Emailed from the school district to transcriptsoti@nysed.gov.
 - Mailed via USPS to the applicant, who would then mail the sealed envelope to OTI, or mailed by the school district.
 - Submitted by a third-party vendor, such as Parchment or National Student Clearinghouse.
- GED submissions can still be submitted by the applicant but must include the GED ID#. *Please see the [OTI website](#) for more information.*

MUST KNOW

Memo on Weather and Extreme Heat Conditions During June and August Regents Examination Period ([attachment](#))

- With the onset of warmer weather, NYSED is reminding administrators of flexibilities that may be used during the administration of June and August Regents Examinations to ensure the health and safety of everyone in school buildings.
- While there are no provisions for weather-related cancellations or rescheduling of June and August Regents Examinations, schools may choose a location to administer the exams that differs from their typical practice should it be deemed necessary based on weather conditions, including extreme heat.
- Exams must remain secured prior to, during, and after transportation to any alternate location.

Facilities Planning – Fire Safety/Project Management System is Now LIVE!

- The Office of Facilities Planning (OFP) has successfully launched the new Facilities Planning - Fire Safety/Project Management application, now available through the [NYSED Application Business Portal](#)
- *Districts may now complete the following tasks through the portal:*
 - **Submit a New Project Request (formerly known as a Letter of Intent). The system will automatically assign a building project number, and a response letter can be printed directly from the system.**
 - **Search for projects and view detailed project information.**
 - **Obtain and print building permits.**

MUST KNOW

Requirement to Adopt Policy Promoting Student Voter Registration([attachment](#))

- Per a 2023 [amendment to section §5-507](#) of NYS Election Law, all public school districts, boards of cooperative educational services (BOCES), charter schools, and non-public schools are required to adopt policies that promote student voter registration and pre-registration.
- Effective this school year (2024-2025), schools must develop and implement a voter registration plan that provides students with access to voter registration and pre-registration applications throughout the school year.
- Beyond registration logistics, schools must educate students on New York State's voter registration and pre-registration requirements, including age, residency, and deadlines. This information should be incorporated into government, civics, and social studies curricula where applicable.

FAFSA Completion Update

- As of April 24, 2025, 53.5% of New York's estimated Class of 2025 has submitted a FAFSA, totaling approximately 113,600 submissions—an increase of nearly 10% compared to last year.
- New York ranks 7th in the nation for FAFSA submissions. The national average is 47.7%.
- Several districts, including Eldred CSD, Herricks Public Schools, and Babylon UFSD, have FAFSA submission rates above 80%.
- Last year, New York students left over \$220 million in Pell Grants unclaimed. Completing the FAFSA is essential to maximizing access to state and federal aid.

Current Diploma Requirements and the Graduation Measures Initiative

- In November 2024, Department staff presented [NY Inspires: A Plan to Transform Education in New York State](#). This plan provides a timeline for implementing the [recommendations of the Blue Ribbon Commission on Graduation Measures](#).
- **Until specific changes are approved by the Board of Regents, the [current graduation requirements](#) remain in effect for all public school students in New York State.** As such, all schools and students must continue to follow

- the requirements of the current system. This includes the current diploma assessment requirements (e.g., Regents Examinations).

Statewide Numeracy Conference on May 13, 2025 [\(attachment\)](#)

- The New York State Education Department (NYSED), in collaboration with BOCES, the Big 5 school districts, and the small city school districts, will be hosting a webinar on Tuesday, May 13, 2025, from 9:00 AM – 3:00 PM at designated BOCES, Big 5, and small city school district sites.
- This event, which will be a hybrid webinar with in-person discussion and presentations, will provide New York State administrators and numeracy leaders with an opportunity to strengthen their knowledge of evidence-based practices for the teaching of mathematics in PK-12 education.
- Individuals must attend in person and register through their local BOCES, Big 5, or small city school district site.
- The keynote speaker, and creator of the briefs, will be Dr. Deborah Loewenberg Ball. Dr. Ball is the William H. Payne Collegiate Professor at the University of Michigan, and the Director of TeachingWorks.

- NYSED and Dr. Ball will release a new series of numeracy briefs that are grounded in research, are written for practitioners, and provide scientific and useful information to support responsible teaching of mathematics across grades PK-12.
